The Rocky Mountain Pig Jig (RMPJ) is a community event where people will enjoy shopping with local vendors, live music, food, family friendly games & activities. The event will focus on a corporate amateur BBQ competition, featuring major businesses from across the Colorado Springs area. All proceeds will benefit NephCure Kidney International, (NKI) a 501(c)3 organization. We are looking for local artisans and goods to showcase their wares during the event. Please fill out the form if you would like to participate.

APPLICATION PROCESS: Applications from Vendors must be accompanied by the following:

- Signed Terms and Conditions
- Photographs, images or web link to your products
- Payment

APPLICATION DEADLINE/SELECTION PROCESS: Application Deadline is April 30, 2023. The Rocky Mountain Pig Jig committee reserves the right to accept or reject entrants at its sole discretion.

FEES: The fee for a 10 x 10 single space is \$60.00. The fee includes one (1) 10x10 designated booth area, and complimentary general admission tickets for two (2) people. **No refunds will be issued.**

SPACE ASSIGNMENTS: All spaces are located on grass/dirt in the field. Spaces are not vehicle accessible for setup. Set up will begin at 10:00 AM, Saturday, June 10th. Vendors should be ready to sell wares and/or begin serving samples at 1 PM and should not begin breakdown before 6:00 PM. Vendors are responsible for their own displays. All garbage or refuse should be disposed of properly on site and not left behind at your booth.

PARKING: Complimentary parking is available in a designated lot at WMMI after load in. Handicapped vendor parking is in a designated location within the parking lot. The Vendor parking lot will accommodate all vendors.

WAITING LIST: Eligible applicants who did not receive a space assignment will be asked to join a waiting list. Available spaces will only be filled from this list.

Terms and Conditions

- 1. Setup/ Break Down:** Vendors may begin setting up at 10:00 AM on Saturday, June 10, and should be ready for the public by 1 PM. Break down may not begin before 6:00 PM and must be completed by 7:45 PM. *Before leaving, be sure your area is clean and trash-free.
- 2. Staffing:** RMPJ Vendor booths must be staffed at all times and intact until The Pit activities close at 6:30 PM. NephCure Kidney International (NKI) is not responsible for merchandise or display materials.
- 3. Exhibitor Items:** Items for sale at the Exhibitor's booth must be predominantly handmade by the Exhibitor. Each Exhibitor must submit a few photographs of his or her craft(s). If participating as a crafter, the Rocky Mountain Pig Jig committee reserves the right to have items removed that are considered not appropriately handmade. Items cannot be simply purchased for resale.
- 4. Exhibitor Vendor Responsibility:** Vendor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. NKI expressly disclaims any responsibility for same. Vendor shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each Vendor is responsible for the conduct of his employees and/or representatives and activities must not detract from the image or welfare of the event.
- 5. Vendor Spaces:** Vendor spaces will be assigned. Placement, flow, electricity access, and competition will be taken into consideration to provide the best experience for fair attendees. If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Spaces are reserved on a first-come first-served basis. Vendors must ensure that none of their display equipment extends beyond their space; this includes any rails, stands or additional equipment.
- 6. One Business per space:** Only one (1) business per space reserved; space may not be sublet or shared without prior approval of an authorized staff of the NKI.
- 7. Acceptance:** The Rocky Mountain Pig Jig committee reserves the right to decline any application for space if it deems such action to be in the best interest of the Rocky Mountain Pig Jig.
- 8. Payment:** The full payment is a non-refundable registration fee for the selected space and is due with the submission of this agreement. This fee will be used to cover incidental costs associated with the production of this event.

9. Electricity: Electricity will be available on the field. Extension cords are not included in the fee and must be provided by the Vendor.

10. Space, Table & Chairs: One (1) 10x10 space will be provided. Each Vendor to furnish chairs, tables, stands and/or props. All spaces will be on grass; it is advised to bring along shims, or blocks of wood to level out the tables, since some areas may include uneven ground. We encourage you to bring banners, swag, and other items to reinforce your brand.

13. Cancellation of space: Application fees are not refundable. NKI is not liable if weather or other conditions prevent the Vendor from attending.

14. Indemnification: Vendor agrees to indemnify and hold harmless NKI and its agents, representatives and volunteers from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Rocky Mountain Pig Jig.

15. No smoking. Tobacco smoking in designated areas only. No recreational smoking allowed.

16. No parking in front of the museum.

17. No pets. Only leashed service animals are allowed on museum grounds.
